Dear Comrades,

BSNLCCWF has decided from the Central Executive Meeting held at Meerut to go on Strike in December, 17. Accordingly, It has been decided in our last secretariat meeting held in Delhi that Federation will go on 2 days Strike on 12th and 13th Dec,17. We have finalized the 6 Point Charter of Demands. We will submit the Strike Notice on 24th November, 17. On 30th November, the Circle and District Union will submit the intimation for Strike to the GM/CGM with a strong mobilization of the workers. A lay out of a Poster will be uploaded in the website so that the Circle Union can print it in the regional language.

Meeting with CMD BSNL

Com. V. A. N. Namboodiri, President, Com. Animesh Mitra, Secretary General, Com. Tapas Kumar Ghosh, Working President met with the CMD BSNL and congratulated him to issue the letter for revision of the wages to the Contract Labourers as per Gazette Notification issued by the Corporate Office, but it is reported that the said order has not implemented at the field level. The leaders has also demanded to sanction wages of the casual workers as per the 7th CPC recommendation and submitted the letter explaining the matter in details. CMD has assured to look into the matter.

Meeting with Chief Labour Commissioner (Central)

Com. V. A. N. Namboodiri, Com. Animesh Mitra, Secretary General, Com. Tapas Kumar Ghosh met with Addl. Chief Labour Commissioner (C) in absence of CLC (C). We have lodged the complaint before the ACLC (C) particularly the case of UP (E) Circle and explained ins and outs about minimum wages, social security measures like EPF, ESI, Gratuity etc. It was also complained that BSNL Management is violating the labour laws in number of Circles throughout the country. The officer has assured us to look into the matter and take necessary action.

BSNLEU demanded wages of the casual workers as per 7th CPC recommendation and endorsement of Gazette Notification for contract workers in the National Council Meeting

Both agenda was taken in National Council Meeting and raised the voice in house by Com. P. Abhimanyu, General Secretary and Com. Animesh Mitra, Vice President. Leaders has clearly mentioned that BSNL has implemented the 7th CPC for ITS and Non Executive whereas BSNL has instructed to continue the 6th CPC to the poor Casual Labourers. After threadbare discussion, the chairperson of the meeting, DIR (HRD) has assured to re-look the matter again. She has also assured that BSNL has already issue the instruction to revise the wages as per the Gazette Notification issued by MoLE. She has also assured that BSNL will examine it so that it is implemented properly. For Gratuity, the Corporated Office has informed that the case will be put up again in the Board Meeting of BSNL as they have collected the required Data from most of the Circles.

Conference & other Organisational News

Jharkhand : - BSNLCCWF, Jharkhand circle, held its 2nd conference at Ranchi on 04.11.2017. Com. Prakash Biplab, State Secretary, CITU, inaugurated the conference of BSNL Daily Bhogi Mazdoor Sangh and explained the role of Modi government on the issue of labour reforms and exploitation of the contract labours. Coms. Bhawan Singh, Circle President, Naresh Lal, Circle Secretary BSNLEU and Sudama Pal, were the other speakers who deliberated their speech on the issues of the casual and contract workers. Com Bhawan Singh and Com. Sudama Pal are re-elected as President and Circle Secretary. About 300 delegates came from all the districts to attend the conference. The union has taken a decision to take affiliation of CITU. The conference has taken a decision to organise March to CGMT Office in the month of December.

2nd Circle Conference of Andhra Pradesh:- The Andhra Pradesh State Conference of BSNL Contract and Casual Employees and Labour Union was held at "Makineni Basava Punnaiah Vigynana Kendram", Vijayawada on 18/11/2017. Com. P. Asokababu, Honorary, President of the Union has presided. About 400 contract and casual workers attended from all the 13 Districts of Andhra Pradesh. Com. Animesh Mitra, Secretary General, BSNL CCWF has explained the necessity of strengthening the Contract and Casual Workers Union and the achievements of BSNL CCWF so far. Office Bearers were unanimously elected with Com A.V.Nageswara Rao as President and Com T.Dharma Rao as General Secretary. Com P.Asokababu is continued as Honorary President. BSNL Employees Union, AP Circle has taken initiative in organizing the Conference, with the help of its Vijayawada SSA branch.

Maharashtra :- The Union in Maharashtra is going to be re-formed shortly. The BSNLEU Maharashtra Circle has arranged a convention at Nasik on 3rd December, 2017. Com. P. Abhimanyu, GS BSNLEU, Animesh Mitra, SG BSNLCCWF and Nazes Nalwade, CS BSNLEU Maharashtra will attend the convention.

Calcutta Telephones Thika Mazdoor Union: - The Circle Conference of the Calcutta Telephones Thika Mazdoor Union is going to be held on 09th and 10th December at Jadavpur.

BSNL Casual Mazdoor Union:- The Circle Conference of the BSNL Casual Mazdoor Union, West Bengal is going to be held on 24th and 25th December in Bankura.
